Drawings Required

- The drawing should be on white letter, legal or tabloid sheets. It should include:
 - the site location plan which need not be to scale but should have sufficient detail to enable the site to be identified
 - its position on the land or the building relationship to adjoining properties
 - the size of the advertisement
 - all existing used fittings, colours and height above the ground
 - projection from a building and the amount of the projection

Owner's Consent

- Under the Regulations before consent is granted for an advertisement to be displayed the permission of the owner of the land or other person entitled to grant permission shall first be obtained.

Other Consents

- Consent under the Town and Country Planning (Control of Advertisements) Regulations 1978 does not relieve the applicant from obtaining any other Consent which may be necessary, e.g. Under the St. Catherine Parish Council Building Act and Regulations made there under.

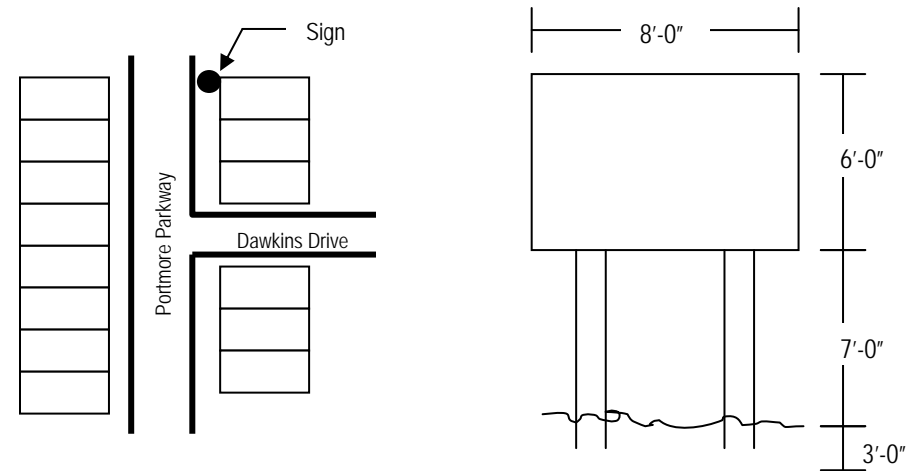
